**I. CALL TO ORDER**

President William Ashley called the Telford Borough Council meeting of December 11, 2023, to order at 7:30 p.m.

**II. INVOCATION AND PLEDGE OF ALLEGIANCE**

The invocation was given by Council Member Robert Jacobus, followed by the pledge of allegiance.

Also in attendance were Mayor Jerry Guretse, Manager Kyle Detweiler, Public Works Director Gary Yoder, Borough Solicitor Jim Jacquette, Chief of Police Randall Floyd, and Recording Secretary Diane Windfelder. In the audience was Dale Nice, John Harrell and his wife, John Waldenberger, John Worthington, and Wendy Leshinskie.

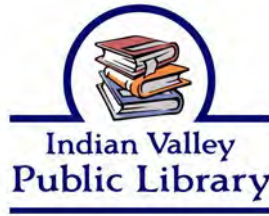

The following is a summary of the Telford Borough Police Department activity for the month of December 2024:

## **Records Destruction**

Now that the Borough Council has issued a resolution, authorizing the destruction of records, arrangements are being finalized to have Richter Drafting and Supply to shred the documents. I will coordinate with the Public Works Director to have his crew assist in transporting the documents, most of which are in the upstairs records area, to the rear of the station when the details are arranged. This is a project that will be completed every 12 to 18 months to ensure that unnecessary records are removed from the inventory.

## **Station Lobby**

The lobby project has been completed and the bulletin boards, television monitor, etc. have been re-hung. A rack for brochures and other informational documents is being purchased and installed. There is minor HVAC work that needs to be completed and arrangements will be made to have that completed.

## **Parking Study**

A parking study is being conducted on Grandview Drive, West Summit Street and Acorn Avenue. This area has been a concern for a while. I am developing some potential solutions and will review with the Public Safety Committee in the near future.

## **Vehicle Maintenance / Repair Bids**

Due to the increased costs of vehicle repairs over the last couple of years, I am looking to find a local repair vendor that will provide a better hourly rate, as well as will offer a fixed rate for certain routine maintenance (oil change, tire rotation, front end alignment, etc.). If some of these issues can be addressed at a lower cost, a considerable amount of savings can occur.

### **Neighbor Dispute**

At last month's regular Borough Council meeting, a Northview Avenue resident expressed concerns that he was having with a neighbor. I spoke to the resident further and learned that, over the last several months, the neighbor was harassing him and his family in some very bizarre ways. I am very familiar with the neighbor in question and have sent him a letter suggesting that he be more conscious of how he is towards those living around him. I hope this resolves the issue.

### **Officer Kyle Heffernan's Return**

Officer Heffernan returned to his position with the police department on December 18<sup>th</sup>. It was a smooth transition since he was only away a few weeks. His return has been helpful since many of the vacant shifts had to be covered with overtime. We are all glad to have him back in the department.

### **Office Renovation**

With Detective Fox's pending retirement, and the addition of new officers, the support office and the detective office needed to be updated and painted. A countertop desk was installed in the support office that will now service three officers. The office was also painted and had new window blinds installed. (The previous venetian blinds were 35 years old) The detective office is being painted and a new window blind is being installed. All of the work was completed in-house.

### **Neighbor Impact Letters**

The man who was living on East Central Avenue and victimized several neighbors is due to go to court in January. He has been charged with numerous criminal acts against the neighbors and there is concern that he will be placed in an alternative program rather than facing the prison time that is justified under the charges. As a result, neighbors were requested to write impact letters so that the judge could see exactly the extent of his harassment. Those letters were collected and were forwarded to the assistant district attorney handling the case. The neighbors were very appreciative of the opportunity to cite their impact and concerns.

### **Corporal Adams Graduates with Master's Degree**

Corporal Adams recently completed his graduate studies and will be awarded a Master of Science Degree in Criminal Justice – Law Enforcement Leadership from Liberty University. This has been a large undertaking and will help prepare Corporal Adams for future leadership roles in the police department. I am very proud of Corporal Adams for completing this program.

### **Business Continuity Plan**

I continue to work on the police department's business continuity plan. My hope was to have this plan completed by the end of the year, however; other projects took precedence. I'm hoping to have the plan completed and distributed in the first month of the new year.

### **Right to Know Issues**

The police department continues to receive Right to Know requests from a resident that has utilized the process in a vexatious manner. In 2023 the police department received 20 Right to Know requests, 17 are from that one resident. Many of the requests turn into appeals due to the

requester asking for records that cannot be released. He challenges those with appeals and with petty follow ups that require significant time from police department staff. His actions, I believe, are simply retaliation for not getting his wish with parking and other issues on his street.

### **Citizens Police Academy**

Two Citizens Police Academy sessions are scheduled. An evening program is scheduled to be held at the Indian Valley Public Library on Tuesday evenings, beginning January 30<sup>th</sup>, and a second program is scheduled for daytime at the Lutheran Community beginning in February. The evening session already has eight registrants and several more are expected to enroll.

### **Summary of Arrests / Investigations (Not Conclusive)**

#### **Juvenile on Juvenile Sexual Abuse Investigation**

A 14-year-old male is alleged to have committed a sexual act on a younger sibling. This is continuation of a reported previous incident that was complicated due to family disfunction. The investigation is continuing.

#### **Fraud Investigation**

A Borough man was defrauded out of \$20,000 through a telephone scam that required him to provide certain banking information. He realized that he made a mistake and reported it promptly. Due to the nature of the fraud, it is unlikely that the scammer is located in the United States, making it highly unlikely that the crime can be solved.

#### **Child Sexual Abuse Investigation**

A child was interviewed for a second time and has provided information alleging sexual abuse by her mother's boyfriend. The allegation involves abuse with an object. This investigation has been extremely complicated by family and guardians interfering and trying to influence the victim child. Several investigatory steps need to take place prior to making a determination in this investigation.

#### **Juveniles Breaking Into Residence**

Several juveniles have been identified as having broke into a residence and stealing liquor. The juveniles are friends with a juvenile that lives in the residence and they have stolen liquor in the past. They have all been released to parents and will participate in a diversion program.

**Drug Arrest**

A man was arrested on drug charges after being observed acting suspiciously in the parking lot of the Circle K store.

**Warrant Arrest**

A man was arrested on an outstanding warrant after he was observed sleeping in his vehicle in the parking lot of the Circle K store.

**Assist Hilltown Township Police with Burglary and Assault in Progress**

Officers assisted Hilltown Police Department with a commercial burglary where the actors also assaulted the property owner. The actors fled on foot through fields and other area parking lots. The search lasted for several hours, and the actors were believed to have escaped the area.

**Shed Collapse**

Officers assisted with the shed collapse in the alley behind North Main Street. There were safety and other concerns. Officers assisted the fire company and code enforcement.

**Accidental Discharge of a Firearm**

A borough resident accidentally discharged a handgun while he was cleaning it. He reported the incident right away for fear that the bullet left the residence and may have entered another property. The officer determined that the round that was discharged was lodged in the outer siding of the residence. No one was injured and no other property damage occurred. No charges are being filed.

**Serious Mental Illness**

A Borough resident, suffering from serious mental illness, has repeatedly called for police assistance due to delusions, etc. Officers were able to get her involuntarily committed for treatment.

**Major Distraction Theft**

Several black or Hispanic men, wearing masks, appeared to play the skill machine at the Circle K store for several hours. On different occasions, one of the men would go to the counter and disturb the clerk and then return with the other men. After the group left, it was discovered that they broke into the machine and removed \$22,000. An investigation is continuing.

Officers arrested and / or investigated several individuals in connection with domestic violence incidents during the month.

**Real Estate Matters** – The Agreement of Sale for 122 Penn Avenue has been approved and all the necessary documents have been fully executed. We are coordinating efforts with the title agency at this time and a 'good faith deposit' has been submitted from the buyer. Settlement date is still to be determined. We did receive the approved 'Waiver of Retroactivity' from the DCNR's offices for Trinity UCC's land acquisition, which is a critical first step in obtaining grant funding. A date will be set for mid-January when representatives of the DCNR will visit the site and explore with us the next steps in this grant application process.

**Franklin Alley Swale Project** – On Tuesday, December 19<sup>th</sup> we received the eagerly anticipated news that the full amount of the grant we applied for, \$146,000, had been awarded to the Borough for this project. Senator Collette and Representative Malagari called our office to personally express their support and relay this extremely positive outcome. We will be scheduling a pre-construction meeting in the coming weeks with the contractor and will also be active in communicating updates with the impacted homeowners.

**Borough Hall Media Improvements** – Altek visited Borough Hall on December 12<sup>th</sup> to review the installation options, equipment selection, and discuss any additional items alongside their wiring partner. I am still not in receipt of a quote to perform the installation, but we will share this info once we have it. There were some alternative solutions presented by the wiring partner that were slightly different than what Altek originally proposed, so the physical installation may take some trial and error to get right.

**Administrative Secretary Hiring** – The Finance & Administration Committee and I conducted interviews with eight prospective candidates between December 12<sup>th</sup> and December 18<sup>th</sup>. An offer was extended to a candidate we were prepared to move forward with, but that candidate withdrew their interest in the position. We had a strong pool of applicants, and an offer will be extended to an alternate which we are equally as excited about and hope to have the alternate selection process wrapped up very quickly.

**BOROUGH OF TELFORD**  
**PUBLIC MEETING ATTENDANCE AND PARTICIPATION POLICY**

**I. INTENT**

It is the intent of this policy to 1) provide a reasonable opportunity for public attendance and participation at public meetings of the Borough Council, Borough Authority, and all other publicly held meetings of the Borough's Boards and other Committees; 2) promote orderly and efficient public meetings of Borough Council and all other Boards; and 3) otherwise comply with the provisions of the Sunshine Act, 65 P.S. §701 et seq. All references to Council President/Chairperson shall include another designated member of Council/Board, in the event of the President's absence.

**II. ATTENDANCE AND NOTICE**

Residents, Tenants, Business Owners and Lessees are welcomed and encouraged to attend all public meetings of the Borough Council. The term 'Residents' is defined as all those who are domiciled within the limits of the Borough of Telford<sup>1</sup>. Notice of all public meetings will be provided in compliance with the provisions of the Sunshine Act.

**III. PUBLIC PARTICIPATION:**

**A. Agenda items**

1. Council/Board will provide a reasonable opportunity for residents to comment specific to an agenda item after there has been a motion and a second on such agenda item, and prior to any vote being taken on such motion.
2. Public comment on agenda items shall not exceed three (3) minutes per person per item. Council President/Chair shall have the discretion to permit a resident to continue commenting for an additional period not to exceed two (2) minutes, after taking into consideration the number of agenda items, the number of residents wishing to comment, the complexity or simplicity of the item, the duplicative or original nature of the comments being provided, the reasonable length of the meeting, and any other factors relevant to the orderly and efficient conduct of the meeting.

**B. Non-Agenda items**

1. Council/Board will provide a reasonable opportunity for residents to comment on any non-agenda items after all agenda items have been addressed, but prior to the adjournment of the public meeting.
2. Public comment on non-agenda items shall not exceed three (3) minutes per person per agenda item. Council President/Chair shall have the discretion to permit a resident to continue commenting for an additional period not to exceed two (2) minutes, after taking into consideration the number of agenda items, the number of residents wishing to comment, the complexity of the item, the duplicative or original nature of the comments being provided, the

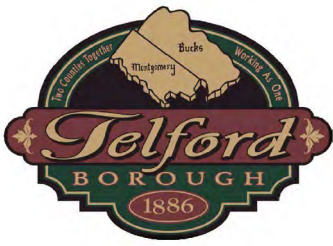
reasonable length of the meeting, and any other factors relevant to the orderly and efficient conduct of the meeting.

**C. Generally**

1. Residents who wish to comment should indicate that intent by raising their hand after the applicable public comment period has been announced.
2. Council President/Chair will then recognize by signal or name that a resident wishing to comment may begin to do so.
3. Each person wishing to comment may put their remark in writing and submit to the Council President prior to the start of the meeting. After the meeting has commenced, upon being recognized, the person commenting shall provide their name, address and group affiliation (if applicable) before addressing Council/Board.
4. Persons wishing to provide written comment or information should bring at least ten (10) copies, one for each Councilperson, one each for the Borough Manager and Borough Solicitor, and one for the record. Additionally, comments may be submitted in advance of the meeting for the Borough Manager's attention via the Borough's website, [telfordborough.org/contact-us](http://telfordborough.org/contact-us).

**CI. Video and Live-Streaming**

1. At the beginning of each meeting, the Council President/Chair shall inquire if any attendee will be audio or video recording and/or live streaming the meeting.
2. If the Borough will be audio or video recording the meeting, the Council President or Chair shall announce, at the beginning of the meeting, that the meeting will be recorded and/or live streamed.
3. Notice that the meeting may be recorded and/or live streamed shall also be published on the meeting agenda.
4. Under state law, the official record of a meeting is the adopted, written meeting minutes.

**WHEREAS**, Borough Council intends to seek assistance from High School or College faculty members and guidance counselors to recommend prospective Junior Council candidates to Council, and Council plans to select a student to serve as Junior Council Person during the school year; and

**WHEREAS**, the Council wishes to extend to the youth of Telford Borough a voice in the operation of this Borough and this Council; and

**NOW, THEREFORE, BE IT RESOLVED** that:

- 1) The Council of the Borough of Telford hereby creates the position of "Junior Council Person."
- 2) The term of office shall be during the student's school year.
- 3) Candidates for the office shall submit a written application to Borough Council highlighting the applicant's interest in the position. After considering all submissions, Borough Council shall appoint student(s) at a regularly scheduled meeting.
- 4) The Junior Council Person shall be a Borough resident and a high school or college student.
- 5) The Junior Council Person shall, upon appointment, take a "Junior Council Person Pledge."
- 6) The Junior Council Person shall not receive compensation.
- 7) The Junior Council Person shall be permitted to attend all public meetings of Council and, at the discretion of Council, shall be permitted to participate fully in committee proceedings, **EXCEPT** that he/she shall not be afforded the right to vote and shall not be permitted to attend executive sessions.
