The Telford Borough Council meeting held this date was called to order at 7:30 p.m. President John Taylor with the following members in attendance: Miles Arnott, William Ashley, Carolyn Crouthamel, Mark Gehman and James Schaeffer. Also present were Mayor David Snook, Manager Mark Fournier, Recording Secretary Megan McShane, Public Works Director Gary Yoder, Solicitor James Jacquette, Phil Crompton from CKS Engineers, Telford Fire Company President Jerry Guretse, Emergency Management Coordinator Robert Sparks, residents Wendy Leshinskie, Lori Rappold and Nicole Spiese, and a reporter. Councilman Robert Baker was absent.

The invocation was given by James Schaeffer, followed by the pledge of allegiance.

#### MINUTES OF PREVIOUS MEETING:

An Arnott/Crouthamel motion carried unanimously (6-0) approving the minutes of the February 3, 2020 Borough Council meeting.

#### TREASURER'S REPORT:

Mr. Fournier also reported that the Borough has taken in 16.57% of its revenues and spent 16.81% of its expenditures for the month of February, 2020.

A Crouthamel/Gehman motion carried unanimously (6-0) approving the Treasurer's Report for February, 2020.

MAYOR'S REPORT: We did not receive a written monthly report for the file.

Mayor David Snook reported that he performed 2 weddings last week and that there were over 1,200 dozen fastnachts made for Little Zion's annual Fastnacht Day sale. He added that fastnachts were shared with area first responders.

POLICE REPORT: We received a written monthly report for the file.

Police Chief Randall Floyd reported that part-time patrol officer Sara Shaeffer is being deployed overseas in June. Officer Shaeffer is in the National Guard and has been promoted twice.

Mayor David Snook complimented Chief Floyd on the excellent job he did on his three comprehensive reports that were submitted for this month's packet.

Councilman Miles Arnott asked Chief Floyd how the amount of overdoses that has occurred so far in 2020 compares to the amount that occurred in 2019. Chief Floyd reported that the amount is the same so far. Mr. Arnott thanked Chief Floyd for his good work and encouraged him to keep it up.

FIRE REPORT: We received a written monthly report for the file.

Mayor David Snook commented that he noticed in the Fire Company's annual report that calls went down in other municipalities in 2019, but not in Telford, and asked if that is unusual. Fire Company President Jerry Guretse confirmed that yes, it is unusual.

LIBRARY REPORT: We received a written monthly report for the file.

PUBLIC WORKS REPORT: We received a written monthly report for the file.

MANAGER'S REPORT: We received a written monthly report for the file.

BUILDING OFFICIAL'S REPORT: We received a written monthly report for the file.

SOLICITOR'S REPORT: We did not receive a written monthly report for the file.

Solicitor Jim Jacquette completed the Deed of Dedication for Arlington Square and it will be recorded shortly. He is also working on Ordinance #421, which is an ordinance that will implement Chief Floyd's request to put a No Parking Here to Corner zone on Summit Avenue 40' back from the curbline intersection with South Main Street.

ENGINEER'S REPORT: We received a written monthly report for the file.

## COMMENTS FROM AUDIENCE:

Bucks County Commissioner Bob Harvie stood and introduced himself to Council; he was elected in November and began his term in January of 2020. Mr. Harvie was a public school teacher for 26 years, and previously served on the Falls Township Board of Supervisors for 16 years; he was Chairman for 12 of those years. Mr. Harvie informed Council that the County is looking to revamp their website, and they are in the process of implementing new voting machines for the 2020 election. Trainings and open demonstrations have begun on the new machines, and there will be a training at the

Sellersville Fire Company on Tuesday, March 3<sup>rd</sup> from 5:00 pm to 8:00 pm. The new machines will have magnifying screens to help people see the ballots better, and there will also be an ADA machine available that will mark the ballot for you – it will have large buttons and braille.

Mr. Harvie reported that the 2020 Census will begin shortly, and there are very basic questions on the form. Information is kept private for 70 years. Census jobs are available at a rate of \$20.00 per hour. Mr. Harvie emphasized the importance of the Census, stating that Pennsylvania was second to last with the accuracy rating on the 2010 Census, and an average of \$2,000 in funding was lost per person who was missed in that Census.

Mr. Harvie also informed the group that the County will be hosting a free Narcan training at Penn Foundation on March 26<sup>th</sup>. Every family who participates will be given a free Narcan kit.
